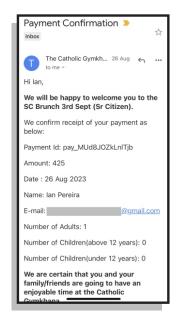

PRESIDENT'S MESSAGE

Dear Member,

On behalf of the Managing Committee of The Catholic Gymkhana Ltd. (CG) I am happy to present our Annual Report for the Financial Year 2023-2024. We share an overview of the financial and non-financial performance and progress during the term.

Operations and Financial Performance

CG continues to make good progress in 2023-24 on the Operations and Revenue realisations after the poor performance in Covid years. The Gymkhana recorded an increase in the total revenue from operations, reaching Rs. 3.46 crores as against Rs. 2.96 crores, achieved last year registering a growth of 17%. The performance of Hire of Gymkhana services and Bar and Canteen receipts have shown an upward trend compared to that of last year. Income from Sports and Games , included in other income grew from Rs. 1.15 crores to Rs. 1.43 crores registering an impressive growth of 24%.

However, as you are aware, the Gymkhana undertook major renovation and structural repairs involving a huge expenditure which dented the surplus of operations of the Gymkhana in the year 2023-24.

On account of the huge expenditure on the repairs and also to an extent loss on writing off some assets resulted in registering a deficit of around Rs. 1 crore as against the surplus of Rs. 7 lakhs achieved in the previous year. We have been constrained to fund these expenses using our Capital / Reserves. The Finance committee, while doing its best to support overall needs, has been urged and encouraged to secure better returns from our investment portfolios while keeping in view an optimal Risk Reward approach. I am sure however, that the initiatives on repairs and renovation we undertook in 2023-24 will improve the working and the Gymkhana will show better results in the years ahead.

The Financial statements have been prepared in accordance with Generally Accepted Accounting Principles in India.

The demography of the city is changing posing challenging situations. The working population is soaring with household incomes recording an upward trajectory, a visible improvement in the quality of life and an increase in disposable incomes. It is therefore imperative for any institution to be well positioned with the changing times to become an integral part of the lives of our members.

As the term of the Managing Committee for the term 2023-24 will expire on the conclusion of the ensuing AGM it is time to reflect on the activities of the past twelve months.

A vast range of events were organised by the sub-committees bringing fun, frolic, joy, happiness, delight and cultural enrichment to members and guests of CG. The CG social calendar was packed with memorable events ranging from Members Nite, Karaoke Nites, Food festivals, Tin and Bottle tournaments, the buzzing Multisport activity which bring CG alive and many more.

It has been inspiring to witness increased participation at our Christmas Carol Nite, Children's Christmas Tree party, Christmas and New Year's Eve celebrations, Easter Dance, Gymkhana Day, Sao Joao and many other events. Kudos to our Entertainment, Cultural and F&B sub-committees for their efforts to make our events a resounding success. It is heartening to see an enthusiastic participation by members which reflects a growing interest for the events hosted at CG. Our Communications sub-committee deserves a special mention for keeping our members informed on the goings on, at the Gymkhana and posting them with updates on events to look forward to at CG. Housie is an ongoing crowd puller with all age groups making it an emerging activity. Actions speak louder than words which are well demonstrated by members and guests who keep participating at every event in large numbers. The Housie sub-committee hosted a variety of Housie games which included Mini Bumper and Bumper Housie games thus providing a thrilling experience for members and guests. Our thanks to the sponsors, Housie sub-committee and staff for their contribution to make every Sunday evening lively, cheerful and rewarding. The positive feedback and participation in large numbers bear testimony to the popularity of Housie at CG.

Much effort has been put in to upgrade amenities and facilities for the comfort and convenience of members and guests. Thanks to the Building Improvements and Special Initiatives committees CG has become a home away from home. Kudos to our House and Staff committee for the initiatives taken to improve housekeeping efficiency. Our future tasks involve repairs to the entrance gate to CG on the main road and signage of the Gymkhana as well as the entrance area to the main building. I wish to thank all our members who have given us positive feedback and expressed satisfaction on the improvements undertaken by the Gymkhana. We welcome constructive suggestions for further improvements that you would like us to make at CG.

The past year has been a testament to CG's commitment to provide a wide range of activities and entertainment for our members. Christmas Carol Nite, one of CG's flagship events was a soul- stirring evening. Presence of members in large numbers made it into a symphony of peace, joy and unity. We appreciate the enormous efforts put in by the Cultural sub-committee to make this event memorable year after year. The children's Christmas Tree party was a proof to the magic of the season through the eyes of the young ones. Their enthusiasm and engagement made it an evening of fun, frolic, innocence and joy that only children bring along with them. It was touching to see the joy and twinkle in the eyes of our guest children from the orphanage who went back delighted and cherished with memories of their experience at our Gymkhana.

The Christmas Dance, with Darren Das & The Sixth Sense, was a night of elegance and celebration with good participation from members and guests adding a touch of glamour to make it a truly memorable event.

The New Year's Eve celebrations with Tammy and Roy, who have gained global popularity, in attendance made it an evening of jubilation bringing 2023 to a close and ringing in 2024 a year of big expectations. The Christmas season witnessed moments of connection, camaraderie, joy and shared memories at CG.

Thanks to our HGS and her team and the House and staff sub-committee who ensured that the Christmas decorations at the Gymkhana looked festive, Christmassy and welcoming to usher in 2024.

The Cultural sub-committee organised its first Inter School Choral Recitation Competition in which 8 schools participated. It was heartening to witness the school children display amazing talent and confidence. The Campion School team was declared winners with a well synchronised and impressive poem. Alexandra Girls High School and St. Anne's Fort were declared 1st Runners -up and 2nd Runners- up respectively. Kudos to the cultural sub-committee team for organising the event which was well coordinated and was a great success.

The Senior Citizens Brunch offered a delightful blend of entertainment, food ,drinks and dance. Our thanks to the Entertainment and F& B sub-committees along with the Caterer for their planning, service and execution.

We need to express our appreciation to our members and guests for their participation in these events and for making them an unforgettable experience.

The Billiards and Snooker sub-committee and the Badminton sub-committee fielded formidable teams for various league matches and tournaments. Kudos to the CG teams for their competitive participation and keeping the CG flag flying high.

The Sporting Activities (SA) sub- committee has done a commendable job in keeping the CG flag flying high. The sub- committee members devoted a great deal of their precious time and energy to form a competitive football team. Their efforts paid off, as the team performed exceptionally well in the domestic football competition and successfully qualified for the play-offs. The progressive run of success in the tournament stood the team in good stead to eventually emerge as the Champions and being crowned champs winning the MFA second division title with their 14th straight win in the final Super - 3 championship match. The CG team gets promoted to the first division for the next season. Well done guys. Our hearty congratulations to each and every member of the victorious CG football team, the coach and the SA subcommittee members for their determination, dedication, efforts and teamwork to bring the Cup home to CG.

The SA sub-committee achieved a milestone by organising a football tournament at the CG turf for the first time, for school children. The event was a resounding success due to their well- coordinated efforts. The participating teams enjoyed competing with each other and carried fond memories of their experience. The dedication and hard work of the Sporting activities sub-committee has significantly contributed to promoting sportsmanship and fostering a sense of community among the youth. Their initiatives have not only strengthened our football team, but has also created a platform for young talent to shine.

My MC colleagues and I look forward to many more sporting events conducted by the SA team.

The MC is committed to provide all the Sports sub-committees the support they need to continue their excellent work and ensure the continued success and growth of sporting activities at CG.

The Cricket sub-committee put up two strong teams for the U-13 and U-16 age groups pulling off some great performances with both the U-13 and U-16 teams reaching the finals. The Senior team made it to the Quarter finals in the two tournaments they participated. It is said that catches win matches and cricket being a game of taking on the chances that come along our CG teams fell a bit short to exploit the chances. On-going through the affiliation's brochure, it will be observed that CG has secured new affiliations across India during the term besides the existing ones and the overseas affiliates. CG added six clubs to our Affiliations during the term and the Affiliations sub-committee is enthusiastic to enhance our Affiliates. A word of appreciation for the Chairman of the Affiliations sub-committee and the team members for their commendable progress and initiatives to enhance the affiliation network. I wish to thank the team for their efforts and extensive coordination with the contractor M/s. Milton Associates.

Our Legal sub-committee merits a special mention and acknowledgement for compiling various exhaustive tender bids, execution of the tendering formalities, compliance of all procedures to conform with regulatory requirements. The legal sub-committee has been called upon on multiple occasions to draft tenders floated inviting bids for structural, catering services and sporting activities. Based on the negotiations concluded by the team of office bearers, service and legal sub-committees, the legal sub-committees expertise to finalise the respective agreements is highly appreciated.

Compliments to the Treasurer, Assistant Treasurer and the Accounting team for handling deftly the Treasury operations as well as the Accounting and Finance work.

The Air Conditioned Billiards Room of The Catholic Gymkhana boasts of 2 tables namely a Sharma S-1 Professional Snooker Table and a Wiraka M-1 Snooker Table which are at par with National level Standards.

Home Snooker and Billiards Tournaments are conducted regularly for the benefit of members.

In the month of November 2023, a 15 Red Snooker Tournament for "THE Charmaine Baptista TROPHY" was held from 19th November 2023. It was sponsored by our own member Mr. John Baptista in memory of his beloved wife Charmaine who left for her heavenly abode suddenly. The finals were played on the 13th December 2023 between Mr. Karl Vaz and Mr. Rohan Pai . Karl being a veteran of many a battles on the Snooker table was the hot favorite for the title but it was not to be as Mr. Rohan Pai won the title by his outstanding potting prowess to be the eventual Winner.

We then had a Home Billiards tournament in the month of April 2024. We have had this tournament after a lull of a few years as it was played more by the old timers who have since hung up their cues. It was named as "The Catholic Gymkhana IGA Home Billiards Tournament "sponsored By Mr. Alex Fernandes, Dr. Glen Mascarenhas and Dr. Ian D'Sousa. FINANCE & INVESTMENT

The Financial Year 2023-24 saw a decent rise in Income from Rs. 2.96 Cr in the previous financial year to Rs. 3.46 Cr in the reporting Financial Year 2023-24. Simultaneously, we witnessed a steep rise in Expenditure from Rs. 3.11 Cr to Rs. 4.51 Cr in the corresponding reporting period, resulting in a Deficit of Rs. 1.04 Cr (before tax and exceptional items). The steep rise in Expenditure was primarily caused due to an inevitable rise in Repairs & Maintenance of our aging building coupled with renovation of some facilities amounting to a collective sum of Rs. 1.35 Cr during the reporting period. Post adjusting for an Exceptional item Profit of Rs. 8.39 Lacs earned on Redemption of some Mutual Funds and Taxes paid, we have reported a Deficit of Rs. 1 Cr for the Financial year.

The Deficit of Rs. 1 Cr during the Financial year has had a negative impact on our Reserves & Surplus within the Balance Sheet. However, this negative impact of Rs. 1 Cr was partly offset through a capitalized earning of Rs. 29.92 Lacs being New Membership Entrance Fees resulting in our Reserves & Surplus closing at Rs. 12.26 Cr for the Financial Year 2023-24 compared to the previous Financial year end Reserves & Surplus of Rs. 12.97 Cr.

The Finance & Investment Committee continues to grapple with the challenge of preserving our corpus in the face of increasing expenditure arising from Repairs & Maintenance of our aging building. There is also a temptation of upgrading our facilities from time to time, in order to attract membership & corresponding footfalls& associated revenues. The Finance & Investment Committee continues its endeavour of making our money work harder for us but such aspirations have limitations of opportunities available. We have scouted and discussed various options. Higher returns on investment options, come with higher risk. We have demonstrated our willingness to take on higher risks in the quest of higher returns but are also sensitive to move the needle judiciously, since these are community funds which call for extra care.

I would like to place on record my sincere thanks to members of the Finance Committee for their assistance, cooperation and support. Thank you Ms. Evette Malgi our Hon. Gen. Secretary who also happens to be the Secretary of the Finance Committee, our Asst. Treasurer Mr. Ian Pereira, members of the Finance Committee Mr. Kenneth Andrade, Mr. Steven Pinto, Mr. Sunil Lobo and Mr. Edwin Roedert. A special word of Thanks to our member Mr. Edwin Roedert who undertook the project of cleaning up our CG Asset Register. The Managing Committee had approved the appointment of an external professional to undertake this long neglected project on behalf of the Managing Committee and at my personal request, Edwin obliged and delivered with many hours of hard work, pro bono. God bless.

CIVIL AUDIT

Given that your Gymkhana Building is located almost on the sea front and is over 50+ years old with direct exposure to the severe Mumbai monsoon experienced in the last couple of months, it had begun to show tell-tale signs of weathering which, for your safety, had to be treated on an urgent basis to avoid further deterioration and or calamities. A structural survey of the Buildingwas therefore undertaken by the Building Improvements committee which included well known Structural / Civil Engineer members, Mr. Philip Remedios and Mr. Albert D'Souza.

A study of their findings was presented to the Managing Committee who authorised a budget for the recommended repairs / treatments required to address structural stress / seepage and leakages / general weathering. Also based on experience of the Gymkhana in the Bar as well as on the advice of the qualified members of the committee, it was decided to do away with all false ceilings in the Gymkhana facilities including in the Card Room , Billiards Room and Sports Diner to enable real-time observation of deterioration herein after. Also, post structural repairs and removal of false ceilings, it was necessary to paint the entire Gymkhana building externally and internally as well, reinstallation of Lights, F ans, Air conditioners and their related wiring/ cabling.

Based on multi party Tenders, which were called for, initial estimated bill of quantities, the committee was able to select the principal Contractor M/s. Milton & Associates at competitive rates. The quality as well as quantity of work was supervised by independent civil engineer authorised by the Gymkhana and certified by Mr. Albert D'souza thereby ensuring a robust three tier check of Invoices prior to payments being effected to the Contractor/s concerned.

ELECTRICAL SAFETY AUDIT

Your overall safety at the Gymkhana being paramount to the Managing Committee, in addition to civil works, it was also decided to conduct an Electrical Safety Audit through an expert agency, selected via competitive tendering, as it was observed that the electrical Wiring / accessories had also aged over time.

A detailed Safety Audit Report highlighted some immediate actions which have since been carried out and others that need to be carried out in the near future. Safety practices of an ongoing nature including periodic maintenance of our electrical substation, Meter Room and Distribution Boxes have been shared with the Gymkhana administration / electricians and we propose to engage with a qualified agency to carry out periodic checks as per industry standards.

SPECIAL INITIATIVES PROJECTS

We have made attempts to start various activities at CG – Yoga, Karate, etc. However, for various reasons the response from Members has not been positive. We shall endeavour to organise some events and programmes that are not usually held at CG during the year.

We plan on having some motivational and career guidance talks for students of higher classes who are on the threshold of deciding on a career.

Where we did succeed is in getting Business Networking to CG. Dimensions Global Christian Chamber of Commerce, an established networking organisation, organised the launch of their South Mumbai chapter, at CG. It was a grand success and was attended by many CG Members and their Guests. Some CG Members have already registered as Dimensions Members and are benefitting from it.

Dimensions intends using CG as a base for some of their monthly meetings. Our Members and their Guests, can attend the meeting as Guests and then choose whether to become a Member of Dimensions. Over the years a lot of Christian Entrepreneurs have benefitted from Dimensions and it is our hope that CG Members and their Guest will also benefit, in the long run.

Online Booking for events: Our online booking process is useful for regular events and major events too. Payment can me made online by various digital means. This saves the time of the Member or Guest who would otherwise have to trek to CG to book for events. It also helps those who have paid online since their entry coupons are ready even before they arrive at CG.

Online booking also helps the Entertainment and F&B sub committees, gauge how many Members / Guests will attend an event so they can make the necessary arrangements. So please help us my using the online booking facility.

Note 14 - Significant Accounting Policies & Notes to Accounts

i) Basis of Accounting

The Financial Statements have been prepared in accordance with the Generally Accepted Accounting Principles in India ("Indian GAAP") to comply with the Accounting standards specified under Section 133 of the Companies Act, 2013, read with Rule 7 of the Companies (Accounts) Rules, 2014 and relevant provisions of the Companies Act, 2013 and other accounting pronouncements of the Institute of Chartered Accountants of India. The financial statements have been prepared under historical cost convention and on accrual basis except in case of assets for which provision for impairment is made and revaluation is carried out and Member's subscription. The accounting policies have been consistently applied by the Company and are consistent with those used in the previous year.

Uses of Estimates

The presentation of financial statements in conformity with Generally Accepted Accounting Principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent liabilities at the date of the financial statements and the results of operations during the reporting period end. Although these estimates are based upon management's best knowledge of current events and actions, actual results could differ from these estimates.

- ii) Admission fees and life membership fees are capitalized to the extent of 90% thereof during the year.
- iii) Depreciation is provided as per the rates specified in Schedule II of the Companies Act, 2013 on the written down value method.
- iv) Long term investments are carried at cost less provision for diminution, other than temporary, in value of such investments.
- v) Current investments are carried at lower of cost and fair value.
- vi) Contributions to provident fund are accounted on actual liability basis.
- vii) Contribution to ESIC is recognized as an expense.
- viii) Right for reservation of seats of Wankhede stadium represent the unamortized balance of the amount paid to the Cricket Association for reservation of the seats for a period of 50 years after writing off Rs 1126/- being charges for the year.
- ix) Pursuant to the directions from the collector, Mumbai city & suburban district, the gymkhana collects Rs 50,000/- each for wedding receptions held on its grounds and pays the same to the collector's office and hence there is no impact on the income and expenditure account of the gymkhana.
- x) In the opinion of the committee, the current assets and loans and advances are approximately of the value stated against each of them if realized in the ordinary course of the business.
- xi) Lease agreement for land with the collector of Mumbai is due for renewal.
- xii) There is an intimation from the Collector of Mumbai towards construction of building amounting to Rs. 12,040,064/-. The CG has contested this claim and the same is being reviewed by the authorities.
- xiii) Contingent liability not provided:

a) During the year assessment was done by department for levy of property tax w.e.f. August, 2020 amount not ascertained.

$xiv)\left(a\right)$ Disclosure of Employee Benefits - Gratuity

The company accounts for Gratuity liability based on independent acturial valuation. All employees are covered under the Group Gratuity Cum Life Insurance Scheme managed by Life Insurance Corporation of India (LIC).

Independent Auditor's Report

To the Members of The Catholic Gymkhana Limited

Report on the Audit of Financial Statements

Opinion

We have audited the accompanying financial statements of **The Catholic Gymkhana Limited** ('the Gymkhana') which comprise the Balance Sheet as at March 31, 2024, the Statement of Income and Expenditure and the Cash Flow Statement for the year then ended and a summary of significant accounting policies and other explanatory information (hereinafter referred to as the "financial statements").

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Companies Act, 2013 ("the Act") in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Gymkhana as at March 31, 2024, its deficit / loss and the cash flows for the year ended on that date.

Basis for Opinion

We conducted our audit of the financial statements in accordance with the Standards on Auditing specified under section 143(10) of the Act (SAs). Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of Financial Statements section of our report. We are independent of the Gymkhana in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India (ICAI) together with the independence requirements that are relevant to our audit of the financial statements under the provisions of the Act and the Rules made there under, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the ICAI's Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion on the financial statements.

Other Information

The Gymkhana's Managing Committee is responsible for the preparation of the other information. The other information comprises the information included in the Annual Report, but does not include the financial statements and our auditor's report thereon.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained during the course of our audit or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information; we are required to report that fact. We have nothing to report in this regard.

Management's Responsibility for the Financial Statements

The Gymkhana's Managing Committee is responsible for the matters stated in Section 134(5) of the Companies Act, 2013 ("the Act") with respect to the preparation of these financial statements that give a true and fair view of the financial position, financial performance and cash flows of the Gymkhana in accordance with the accounting principles generally accepted in India, including the Accounting Standards specified under Section 133 of the Act, read with the Companies (Accounts) Rules, 2014. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding the assets of the Gymkhana and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Gymkhana's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Gymkhana or to cease operations, or has no realistic alternative but to do so.

The Managing Committee is responsible for overseeing the Gymkhana's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with SAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with SAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal financial controls relevant to the audit in order to design audit procedures that are appropriate in the circumstances. Under section 143(3)(i) of the Act, we are also responsible for expressing our opinion on whether the Gymkhana has adequate internal financial controls system in place and the operating effectiveness of such controls.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.

- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Gymkhana's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Gymkhana to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

Report on Other Legal and Regulatory Requirements

1. As required by the Companies (Auditor's Report) Order, 2020 ('the Order') issued by the Central Government of India in terms of sub-section (11) of section 143 of the Act, we give in the "Annexure A", a statement on the matters specified in paragraphs 3 and 4 of the Order.

2. As required by Section 143 (3) of the Act, we report that:

- a) We have sought and obtained all the information and explanations, except for the matter described in the Basis for Qualified Opinion section of our report, which to the best of our knowledge and belief were necessary for the purpose of our audit;
- b) In our opinion, proper books of account as required by law have been kept by the Gymkhana so far as it appears from our examination of those books, except that it does not have a facility of daily back up of books of accounts.
- c) The Balance Sheet, the Statement of Income and Expenditure, and the Cash Flow Statement dealt with by this Report are in agreement with the books of account;
- d) In our opinion, the aforesaid financial statements comply with the Accounting Standards specified under Section 133 of the Act, read with Companies (Accounting Standards) Rules 2006 (as amended) specified under section 133 of the Act, read with the Companies (Accounts) Rules, 2014;
- e) On the basis of the written representations received from the members of the Managing Committee as on March 31, 2024 taken on record by the Managing Committee, none of the members are disqualified as on March 31, 2024 from being appointed as a director in terms of Section 164 (2) of the Act;
- f) The modifications relating to the maintenance of accounts and other matters connected therewith are as stated in paragraph '2.(b)' above on reporting under Section 143(3)(b) of the Act.
- g) With respect to adequacy of internal financial controls system with reference to financial statements of the Gymkhana and operating effectiveness of such controls, refer to our separate report given in "Annexure B";
- h) In our opinion and to the best of our information and according to the explanations given to us, no remuneration was paid by the Gymkhana to its managerial personnel during the year. Hence provisions of section 197 read with schedule V of the Act is not applicable in this context.

- i) With respect to the other matters to be included in the Auditor's Report in accordance with Rule 11 of the Companies (Audit and Auditors) Rules, 2014, as amended from time to time, in our opinion and to the best of our information and according to the explanations given to us:
 - i. The Gymkhana has disclosed the impact of pending litigations on its financial position.
 - ii. The Gymkhana did not have any long-term contracts including derivative contracts for which there were any material foreseeable losses;
- iii. There are no amounts which were required to be transferred to the Investor Education and Protection Fund by the Gymkhana.
- iv. (a) The management has represented that, to the best of its knowledge and belief, no funds have been advanced or loaned or invested (either from borrowed funds or share premium or any other sources or kind of funds) by the Gymkhana to or in any other persons or entities, including foreign entities ("Intermediaries"), with the understanding, whether recorded in writing or otherwise, that the Intermediary shall, whether, directly or indirectly lend or invest in other persons or entities identified in any manner whatsoever by or on behalf of the Gymkhana ("Ultimate Beneficiaries") or provide any guarantee, security or the like on behalf of the Ultimate Beneficiaries;
 - (b) The management has represented, that, to the best of its knowledge and belief, no funds have been received by the Gymkhana from any persons or entities, including foreign entities ("Funding Parties"), with the understanding, whether recorded in writing or otherwise, that the Gymkhana shall, whether, directly or indirectly, lend or invest in other persons or entities identified in any manner whatsoever by or on behalf of the Funding Party ("Ultimate Beneficiaries") or provide any guarantee, security or the like on behalf of the Ultimate Beneficiaries; and
 - (c) Based on audit procedures performed, nothing has come to our attention that causes us to believe that the representations under sub-clause (i) and (ii) of Rule 11(e), as provided in (a) and (b) above, contain any material misstatement.
- v. The Managing committee members of the Gymkhana have not proposed or paid any dividend for the year.
- vi. Based on our examination which included test checks, the Gymkhana has used an accounting software for maintaining its books of account which has a feature of recording audit trail (edit log) facility and the same has operated throughout the year for all relevant transactions recorded in the software. Further, during the course of our audit we did not come across any instance of audit trail feature being tampered with.

As proviso to Rule 3(1) of the Companies (Accounts) Rules, 2014 is applicable from April 1, 2023, reporting under Rule 11(g) of the Companies (Audit and Auditors) Rules, 2014 on preservation of audit trail as per the statutory requirements for record retention is not applicable for the financial year ended March 31, 2024.

The Gymkhana's internal financial controls with reference to financial statements is a process designed to provide reasonable assurance regarding the reliability of financial statements and the preparation of financial statement for external purposes in accordance with generally accepted accounting principles. The Gymkhana 's internal financial controls with reference to financial statements includes those policies and procedures that

(1) pertain to the maintenance of records that, in reasonable detail, accurately and fairly reflect the transactions and dispositions of the assets of the Gymkhana; (2) provide reasonable assurance that transactions are recorded as necessary to permit preparation of financial statement in accordance with generally accepted accounting principles, and that receipts and expenditures of the Gymkhana are being made only in accordance with authorizations of management and directors of the Gymkhana; and (3) provide reasonable assurance regarding prevention or timely detection of unauthorized acquisition, use, or disposition of the Gymkhana's assets that could have a material effect on the financial statement.

Inherent Limitations of Internal Financial Controls with reference to Financial Statements

Because of the inherent limitations of internal financial controls with reference to financial statements, including the possibility of collusion or improper management override of controls, material misstatements due to error or fraud may occur and not be detected. Also, projections of any evaluation of the internal financial controls with reference to financial statements to future periods are subject to the risk that the internal financial controls with reference to financial statements may become inadequate because of changes in conditions, or that the degree of compliance with the policies or procedures may deteriorate.

Disclaimer of Opinion

According to the information and explanation given to us, the Gymkhana has not established its internal financial control over financial reporting on criteria considering the essential components of internal control stated in the Guidance Note on Audit of Internal Financial Controls Over Financial Reporting issued by the Institute of Chartered Accountants of India, even though the Gymkhana has existing internal Standard Operation Procedures for its various functions prepared in accordance with the operational functionality of the field in which the Gymkhana operates. Because of this reason, we are unable to obtain sufficient appropriate audit evidence to provide a basis for our opinion whether the Gymkhana had adequate internal financial controls over financial reporting and whether such internal financial controls were operating effectively as at March 31, 2024.

We have considered the disclaimer reported above along with implemented checks and balances for various functions of the Gymkhana in determining the nature, timing, and extent of audit tests applied in our audit of the financial statements of the Gymkhana, and the disclaimer does not affect our opinion on the financial statements of the Gymkhana.
